be pleased to state:

- (b) if so, whether it is due to the decision not to entertain applications for the supply of machinery under hire purchase scheme by National Small Industries Corporation:
- (e) whether it is a fact that the printers are not getting the same import facilities as are given to newspaper establishments; and
- (d) if so, what action Government propose to take to remove the difficulty of the printing industry?

The Minister of Industry in the Ministry of Commerce and Industry (Shri Kanungo): (a) and (b). Government have received certain representations against their decision not to allow the National Small Industries Corporation to accept applications for supply of printing machinery on hire purchase. Government, however, do not consider that the printing industry is facing any great difficulties because of this decision.

- (c) Quality printers and newspaper establishments are allowed the same facilities for direct import as 'Actual Users'. To meet the requirements of printers who are not considered to be quality printers, the established importers are allowed a quota.
