रेलवे मंत्रालय में उपमंत्री (श्री से० वें० रामस्वामी):(क) ग्रभी तक रेल के सवारी डिब्बों का निर्यात नहीं हुग्रा है । इसलिये प्रत्यक्ष रूप से यह अनुमान नहीं लगाया जा सकता है कि भारत में तैयार डिब्बों की विदेशों में बस्तूतः कितनी मांग है । बाहरी देश ग्रामतौर पर रेल डिब्बों की खरीद विश्व-व्यापी टेण्डरों के स्राधार पर करते हैं जिनमें कीमत के ग्रलावा, ग्रास्थगित भगतान की सुविधा, सहबद्ध कर्ज़ (Tied Loan) की व्यवस्था ग्रादि भी निर्णायक तथ्य होते हैं। विगत वर्षों में हमने रेल डिब्बों के जो भाव दियं थें. वे ग्रन्य भावों के मकावले के थे. भौर समय समय पर विदेशी आगन्तुकों श्रीर ग्रन्य सम्बन्धित लोगों ने भारत में तैयार डिब्बों में काफी दिलचस्पी दिखायी है।

- (ख) यदि निर्दिष्ट म्रार्डर मिलें तो कुछ डिब्बे निर्यात किये जा सकते हैं।
- (ग) १९६३ से स्रव तक सवारी डिब्बों का उत्पादन बहुत कुछ उतना ही रहा है जितना १९६२ में था, ग्रर्थात् दोनों वर्षों में प्रतिमास लगभग १४ डिब्बे तैयार किय गए।

वर्ष में इन कारखानों में कमशः ७००, २०० ग्रीर ३७० सवारी डिब्बे तैयार करने का लक्ष्य रखा गया है।

Will the Minister of Food and Agriculture be pleased to state:

- (a) whether Government have decided to use special powers under D.I.R. to regulate sugarcane supplies in areas reserved for the factories;
- (b) whether Government have decided to introduce licensing of units manufacturing Gur and Khandsari; and
- (c) if so, its effect on the Gur and Khandsari production?

The Minister of State in the Ministry of Food and Agriculture (Shri A. M. Thomas): (a) Government have

assumed powers under D.I.R. to regulate sugarcane supplies in areas reserved for factories and have delegated them to State Governments. who are expected to use the same by due regard to circumstances obtaining in each area.

- (b) Yes, Sir, only units operated by commercial operators and by sugarcane growers individually on their own fields or in their own houses.
- (c) It is hoped the step will secure an equitable distribution of sugarcane supplies between producers of sugar, gur and khandsari.

Brahmaputra Basin Food Output

The Minister of State in the Ministry of Food and Agriculture Ram Subhag Singh): (a) and (b). The Food and Agriculture Organisation Report estimates that the production Ganges-Brahmaputra of the can be increased four-fold in course of forty years. The potentialities of this region for increased production are well-known and are being explored and exploited under different development programmes are similar to those mentioned in the Report. The report is only on estimate of potentialities of this region. To realise that potential, detailed studies would have to be made determine the projects and programmes that could be undertaken. is a continuing process. In the first

ten years of planning, the total agricultural production of our country. taken as a whole, increased by about 40 per cent and this rate of increase itself suggests that in a period forty years our production can be increased to about 385 per cent of the production at the beginning of such a long period. And this for the entire country which contains many other areas. On the basis of actual achievement itself, therefore. the Government of India would agree that production of this region can be imcreased four-fold over a period forty years.
