#### Automatic Check-out Equipment in Air Corporations

Will the Minister of Transport be pleased to state:

(a) the number of Tape-controlled Recording Automatic Check out Equipment (T.R.A.C.E.) in use in our Air Corporations to perform a comprehensive electronic inspection;

(b) whether any attempts have been made to manufacture this equipment in our country;

(c) if so, when and by whom; and

(d) the special advantages derived by this equipment?

#### The Deputy Minister in the Ministry of Transport (Shri Mohiuddin):

(a) and (d). The Indian Airlines Corporation do not have any such equipment in use. The Air-India are having on their Boeing 707 Jet Aircraft the following two items utilising a tape in their operation:—

(i) *Tape Reproducer*—This equipment is manufactured in U.S.A., and is specially built for installation and use in aircraft. It utilises special recorded 2-track spool for providing music in the passenger cabin as an entertainment facility.

(ii) *Flight Recorder*—This is an electro-mechanical unit providing continuous permanent recorded data

of flight parameters like airspeed, altitude heading, acceleration, against lapsed time. This unit is also manufactured in U.S.A., and approved by Federal Aviation Agency for use on 707 airplanes. The recording tape used is a special aluminium foil. The data so obtained could be used for assessing the flight data, incidents and for accident investigation.

(b) There are no plans at present to manufacture Tape Controlled Checkout Equipment in India.

(c) Does not arise.
