#### Tobacco Seeds

975. Shri Rameshwar Tantia: Will the Minister of Food and Agriculture be pleased to state:

- (a) the reasons for prohibiting the import of tobacco seeds by all except the Central Tobacco Research Institute in Rajahmundry in Andhra Pradesh; and
- (b) what procedure will be adopted by the institute for the distribution of seeds thus imported?

The Minister of State in the Ministry of Food and Agriculture (Dr. Ram Subhag Singh): (a) To prevent possible introduction into India of "Blue Mould" which is a very destructive tobacco disease.

(b) The seeds will be imported by the Central Tobacco Research Institute, Rajahmundry in small quantities intended for experimental purposes only and not for distribution.

### Road Bridge Over Ganga

976. Shri Raghunath Singh: Will the Minister of Transport be pleased to state whether cracks have been reported in the road bridge over the Ganga between Kanpur and Lucknow?

The Minister of Shipping in the Ministry of Transport (Shri Raj Bahadur): The road bridge over the Ganga, between Kanpur and Lucknow is an old bridge taken over from the Railways and decked for road traffic. Cracks have been observed in some portions of the concrete of the upper deck of the bridge. Necessary repairs are in full swing and will be completed shortly.

#### Land Acquisition Committees

977. Shri P. Venkatasubbaiah: Will the Minister of Food and Agriculture be pleased to state:

- (a) whether the State Governments have set up Land Acquisition Committees as contemplated in the Land Acquisition (Companies) Rules, 1963 laid on the Table on the 13th August, 1963; and
- (b) the composition of these Committees and the States which have also issued necessary instructions in this regard?

The Minister of State in the Minisof Food and Agriculture (Dr. Ram Subhag Singh): (a) and (b). Land Acquisition Committees have already been set up by the Governments of Gujarat, Orissa, Bihar, Uttar Pradesh, Maharashtra, West Bengal, Tripura. Composition of these Committees conform to the provision therefor under Rule 3(2) of the Land Acquisition (Companies) Rules 1963. Setting up of such Committees Governments is under other State their consideration. Necessary instructions have also been issued by the Governments of Gujarat, Uttar Pradesh, Manarashtra, West Bengal,
