drawn to a recent news-item emanating from London to the effect that the Chinese Government is monitoring publicity directives of the Indian Ministry of External Affairs to Indian Missions abroad; and

(b) if so, the steps taken to counteract Chinese action?

The Minister of State in the Ministry of External Affairs (Shrimati Lakshmi Menon): (a) Yes, Sir. A spokesman of the Ministry of External Affairs explained on September 25 (on dav the newspaper report appeared) that the implication in the report that some secret code used by the Ministry of External Affairs had broken was incorrect. been spokesman explained that the reference was to ordinary news transmissions sent to our missions abroad in open morse code through normal commercial channels. These transmissions can be picked up by anyone and the Chinese have, in fact, been monitoring them for many years.

(b) Since no secret code is involved in these transmissions, the question of taking steps to counteract Chinese action in the matter does not arise.

Quarters for Army Personnel

*13. Shri A. V. Raghavan: Shri Pottekkatt:

Will the Minister of Defence be pleased to state:

- (a) whether there is an acute scarcity of family quarters for allotment to officers and Jawans in the armed forces;
- (b) if so, the steps Government have taken to provide more family quarters; and
- (c) the amount sanctioned for this purpose for 1963-64 and whether Gov-

ernment propose to increase this allotment in view of the additional requircments on account of the Emergency?

The Minister of Defence (Shri Y. B. Chavan): (a) Yes, Sir; there is considerable shortage of family accommodation at present.

- (b) Accommodation is being provided to the extent possible by additional hirings and requisitions and construction of fresh accommodation by Government. During the years 1959-60 to 1962-63 Rs. 15.42 crores have been spent for the provision of married accommodation. Since the emergency projects costing approximately Rs. 6.50 crores have been released for execution.
- (c) An amount of approximately Rs. 4 crores is expected to be spent during the current financial year. In view of the higher priority projects which are immediately required it is not possible to do better this year but it is hoped to make a bigger allocation for this in the next financial year.

This Government have still to consider this resolution.

The Deputy Minister in the Ministry of External Affairs (Shri Dinesh Singh): (a) No, Sir. As against passports for the U.K. issued to 30,251 Indian nationals during the year ending 30th June, 1962, passports were issued to only 3,758 Indian nationals (excluding wives and children) during the year ending the 30th June, 1963.

- (d) According to statistics issued by the British Ministry of Labour, Employment Vouchers to 20,317 Indians

nationals were issued during the period July 1, 1962—when the Commonwelth Immigrants Act was introduced—to September 27, 1963. The number of applicants for Employment Vouchers during this period totalled 1.35.710.
