## Indians in U.K.

- Dwivedi: 3. Shri Surendranath Will the Prime Minister be pleased to state:
- (a) whether Government have received any memorandum from the Indian Workers' Association of Great Britain (Coventy branch) concerning Indian nationals residing in United Kingdom:
  - (b) the nature of the memorandum;
- (c) whether they have represented about any specific difficulties experienced by Indian nationals there;
- (d) if so, the steps taken to remove those difficulties?

The Prime Minister Minister of External Affairs and Minister of Atomic Energy (Shri Jawaharlal Nehru): (a) Yes Sir.

- (b) The memorandum contains request that the continued stay in U.K. of such Indian nationals as had gone there in search of employment on improper travel documents should be regularised.
- (c) Yes, Sir. They have represented that on account of their inability to get Indian passports, they stranded in Britain, and were able to travel either to India or to any other country. Some of were, in consequence, forced to seek British citizenship.
- (d) The matter is being examined and a decision will be taken soon.

## M.E.S. Bikaner

## 4. Shri Karni Singhji: Shri V. B. Deo:

Will the Minister of Defence be pleased to state:

(a) whether any retrenchment of workers under the Garrison Engineer, M. E. S., Bikaner (Rajasthan)

- been effected during 1962-63 and if so, the number of workers so retrenched, and the reasons therefor;
- (b) whether during the corresponding period any recruitment of workers has taken place in the said department and if so the number workers so recruited;
- (c) whether the workers retrenched were given preference for re-employment; and
  - (d) if not the reasons therefor?

The Minister of Defence (Shri Y. B. Chavan): (a) 167 casual workers of Garrison Engineer, M.E.S., Bikaner were discharged from service during 1962-63. They were employed specific jobs for specified periods, and their services were terminated at the end of these periods.

(b) to (d). 243 casual workers were recruited during this period at different times and the "retrenched" workers were given preference the time of recruitment: out of 167 persons 124 were re-engaged. rest could not be re-employed as they belonged to categories other than those required, or were not available for employment when the vacancies occurred.

## Third Five Year Plan

5. Shri Sham Lal Saraf: Will the Minister of Planning be pleased state the Central outlay (State-wise) for the Third Five Year Plan. the estimated individual States' contribution from their own resources?
