The Minister of Defence Production in the Ministry of Defence (Shri Raghuramaiah): The Project Reports on Airframe and Aero-Engine Factories, since completed by Indian Team in consultation with Russian Specialists, are currently under examination by the Government.

Land has been acquired at Koraput in Orissa and is being acquired nt Nasik. The State Governments have been entrusted with Civil Construction Work as agents of the Central Government. Administrative approval for first Phase construction programme amounting to Rs. 3.5 crores has already been issued for the Airframe Factory, Nasik. For the Aero-Engine Factory, Koraput, the first Phase estimates amounting to Rs. 3:16 crores are under examination for administrative approval. A site near Hyderabad has been selected for the foctory to be established for the manufacture of electronic components.
