The Minister of Health (Dr. Sushila Nayar): (a) and (b). In 1959 the Medical Council of India appointed an Under-graduate Medical Curriculum Revision Sub-Committee to recommendations with regard to the revision of the Under-Graduate medical curriculum, in the light of the latest developments and advancements in medical education all over the world. The object was to so devise the medical course in India as to give the new medical graduates the requisite knowledge and skill to practise medicine within the shortest possible time and suitable to the needs of the country. The recommendations of the Sub-Committee were considered by the Medical Council of India and were forwarded on 15th June, 1962 to all the Universities most of whom have put them into operation with effect from the academic session of 1963.
