

(ग) यदि लक्ष्य के अनुसार काम होने में गति धीमी रही है तो उसका क्या कारण है और उसको दूर करने के लिये क्या किया जा रहा है ?

शिक्षा मंत्रालय में उपमंत्री (श्री भक्त बशन) : (क) से (ग). राष्ट्रपति के २७ अप्रैल, १९६० के आदेशानुसार, मार्च १९६१ में यह निश्चय किया गया था कि नियमों, पुस्तिकाओं, अन्य क्रियाविधिक साहित्य तथा भारत सरकार के कार्यालयों में प्रयोग होने वाले फार्मों का अनुवाद १ अप्रैल, १९६३ तक पूरा कर दिया जाय। तदनुसार पद बनाने तथा उनके लिये प्रचलित क्रियाविधिक के जरिये अपेक्षित कर्मचारियों को भर्ती करने के लिये कार्रवाई की गई। ऐसी नियुक्तियां करने में कुछ समय लगा। साथ ही साथ भारत सरकार के मंत्रालयों से अनुरोध किया गया कि वे ऐसा साहित्य जिसका अनुवाद होना है, केन्द्रीय हिन्दी निदेशालय को भेजें। १ अप्रैल, १९६३ को फार्मों के अनुवाद कार्य की स्थिति इस प्रकार थी :—

Sports Coaching Camps

2202. Shri Ram Harkh Yadav: Will the Minister of Education be pleased to state:

(a) whether it is a fact that in collaboration with the National Institute of Sports, Patiala temporary coaching camps are going to be held at Dehra Dun and Naini Tal by the end of April, 1964; and

(b) if so, the details of the training?

The Deputy Minister in the Ministry of Education (Shri Bhakt Darshan): (a) The U.P. Council of Sports propose to organise certain coaching camps at Dehra Dun, Al-mora or Roorkee sometime in May-June, 1964 and for this purpose they have asked for the services of coaches from the National Institute of Sports, Patiala. The matter is receiving the attention of the Institute.

(b) The coaching camps are proposed to be conducted in athletics, cricket, basket ball, table-tennis, volley ball, badminton and tennis.

The Deputy Minister in the Ministry of Home Affairs (Shrimati Chandrasekhar): (a) and (b). In this connection, attention is invited to the Memorandum submitted to the House on the 3rd September, 1956 along with the report of the Commission and to the reply given to the unstarred questions No. 903 on the 14th August, 1961 and No. 2372 on 31-5-1962.

Merit-Cum-Means Scholarships

(a) the number of merit-cum-means scholarships allotted to each technical institute in Bihar during 1963-64;

(b) the amount given to each institute during the same period; and

(c) the amount of money given to Bihar for scholarships to be given to the pupils of other backward classes under the same Scheme?

The Minister of Education (Shri M. C. Chagla): (a) In addition to the renewal of scholarships allotted previously, the number of fresh scholarships to the first year students allotted to technical institutions in Bihar during academic session 1963-64 under the Merit-cum-Means Scholarships Scheme is given in the Statement laid on the Table of the House [Placed in Library. See No. LT-2727/64].

Higher Secondary Schools in South Andamans

2205. Shrimati Savitri Nigam: Will the Minister of Education be pleased to state:

(a) whether it is a fact that Hindi and Urdu are the two media of instructions in the higher secondary schools in south Andamans (Port Blair); and

(b) if so, whether separate teachers qualified to teach different subjects in

Hindi or Urdu have been provided in those schools?

The Minister of Education (Shri M. C. Chagla): (a) Yes, Sir.

(b) The detailed information is being collected and will be laid on the table of the Lok Sabha in due course.

Allahabad Pre-Examination Coaching Centre

Will the Minister of Home Affairs be pleased to state:

(a) whether it is a fact that Government have opened a pre-examination coaching centre for Scheduled Caste/Scheduled Tribe candidates at Allahabad;

(b) the number of teacher-student ratio in the said school; and

(c) the total amount including fees, boarding spent per student?

The Deputy Minister in the Ministry of Home Affairs (Shrimati Chandrasekhar): (a) Yes.

(b) All the teachers are employed only part-time. The ratio of part-time teachers to students as on 31-12-1963 was 36:52 There are a large number of subjects to be taught.

(c) About Rs. 200 per student per month during 1962-63. This includes all the expenditure.
