Written Answers

The Minister of State in the Ministry of Railways (Dr. Ram Subhag Singh): The total number of passengers detected travelling without tickets was 261,288; the amounts of fares, excess charges and fines recovered were Rs. 5,59,021, Rs. 2,28,460 and Rs. 18,888 respectively.

#### Freight Rates for Iron

- 672. Shri R. G. Dubey: Will the Minister of Railways be pleased to state:
- (a) whether there is any proposal to reduce the Railway freight rates for iron and steel scraps to encourage their collection in up-country centres in view of the assurance given by the Ministry of Steel to the Iron and Steel Scrap Association of India; and
- (b) if so, the nature of the concession proposed to be offered?

The Minister of State in the Ministry of Railways (Dr. Ram Subhag Singh): (a) and (b). A request for reduction in freight rates generally for Iron and Steel Scrap has been under examination and has not been agreed to. In the Budget proposals the rate for this scrap has, in fact, been enhanced.

The further question of feasibility of a reduction in freight rates for export traffic in Iron & Steel scrap is under examination in consultation with the Ministry of Commerce.
