- (i) Minimum of 40 paise for the first 1½ kilometre or less; and
- (ii) 10 paise for each subsequent half kilo-metre or part thereof.

(c) and (d). A proposal to import some tractors from U.S.S.R. and Czechoslovakia is under consideration. As the import has necessarily to be limited, some portion of the demand will remain unsatisfied.

(e) The import of tractors takes place through the State Trading Corporation. The Corporation fixes the prices at which these should be sold by the agents. Check on selling prices is exercised through periodical sales returns submitted by the agents. There is no control on price of indigenously manufactured tractors. The question of fixing the sale prices of indigenous tractors is under consideration.
