Tungábhadra Projest

1156. Shri Gadilingum. Gowe: Will the Minister of Brigation and Power by pleased to state:

- (a) the villages which will be irrigated in Allur Tatuk of Eurnool District of Andhra Pradesh by High level channel of Tungabhadra Project;
- (b) the extent of land in each of the villages that can be irrigated; and
- (c) the names of the villages to which water will be given for next crops and the extent thereof?

The Minister of Irrigation and Power (Dr. E. L. Rae): (a) Localisation of Ayscut has not yet been carried out in Allur Taluk and so the State Government has reported that it is not possible at this stage to indicate the villages which will be irrigated.

(b) and (c). Do net arise.

Sharat Sewak Samaj

1136. Shri Gadilingana Gowd: Will the Minister of Planning be pleased to state:

- (a) whether it is a fact that the Planning Commission have set up a asb-committee of the Coordination Committee for the Public Cooperation to varify the grants given to the Bharat Sewak Samaj through different Ministries:
- (b) the amounts given by each Ministry to Bharat Sewek Samaj and for what purposes during 1965-66 and 1998-67;
- (c) whether any representations have been received to the effect that funds of the Sharat Sewak Sama; are being misused;

- (d) if so, the action taken in the matter; and
- (e) whether there is any machinery to evaluate the work done by the Bharat Sewak Samaj?

The Minister of Planning, Petrelevin and Chemicals and Social Welfare (Shri Asaka Makta): (a) Yes, Sir. The Sub-Committee of the Coordination Committee of Public Cooperation reviews periodically the grants given to the Bharat Sewak Samaj by the different Ministries.

- (b) A statement is laid on the Table of the House. [Placed in Lib-rary. See No. LT-49167].
- (c) and (d). Some complaints were received in the Planning Commission regarding infringement of the conditions of the Government grant-in-aid by the Bharat Sewak Samaj but these could not be substantiated.
- (e) No separate machinery for evaluating the work of Bharat Sewak Samaj exists but the Plan programmes undertaken by Bharat Sewak Samaj on behalf of Government of India have been evaluated by the Programme Evaluation Organisation and other ad hoc Committees from time to time.

T.B. Clinics

1257. Shri Bohuti Mishra: Shri K. N. Tiwary:

Will the Minister of Health and Family Planning be pleased to state:

- (a) whether Government are considering a proposal to open a T.B. Clinic in every district of the country; and
 - (b) if so, the details thereof?

The Minister of Health and Family-Plausing (Dr. S. Chandrasokhar): (a) Yes.

(b) Under the National TB Control Programme, it is proposed to establish a TB Clinic in every district of the country to undertake diagnostic treatment and preventive on a domiciliary basis. It is further proposed to extend these by integrating the existing in the various health and institutions in the districts, under the supervision and guidance of the District TB Clinic, so that the patients can avail themselves of these services rearest to their homes.

वैद्रोतिषण और रतायम, योचना तथा समाण करूपाण मंत्रालय में राज्य-मंत्री (श्री रणुरालया): (क) धौर (ख) इस समय बनाये गये अस्थायी प्रोदाम के अनुमार बरौनी परियोजना का निर्माण धगमे वयं के प्रारम्भ नक मुक्त होगा और 1971 के मुक्त में कारखाने के चामू होने की माणा है। यह सब कुछ इस वयं अस्तूबर तक मृमि की उपलब्धी धौर दिसम्बर नक बिदेशी मुद्रा के मंत्रीयजनक बन्दीबर्स्स भीर प्रवायक खुण ठेकी के अन्योदन पर निर्भर होगा।

Liquified Petroleum Gas

1160. Shri K. N. Pandey: Shri N. P. Yadab;

Will the Minister of Petroleum and Chemicals be pleased to state:

(a) whether it is a fact that due to the non-availability of Cylinders, ties liquided petroleum gas has not been introduced in all important towns of the country; and

(b) if so, the steps taken to remove this bottleneck?

The Minister of State in the Ministry of Potreleum and Chemicals and of Planning and Sectal Welfare (Shri Ragha Ramiah): (a) Yes, Sir, due to shortage of suitable steel for fabrication of LPG Cvlinders.

(b) Steps have been taken to develop the production of suitable steel indigenously for the fabrication of cylinders. Meanwhile, 1200 tonnes of such steel are being imported.

Central Assistance given to Orison for Plan Executions

- (s) the amount of Central assistance to be given to Orissa for plan executions during 1967-58;
