The Minister of State in the Ministry of Food, Agriculture, Community Development and Cooperation (Shri Annasaheb Shinde): (a) The maintenance expenditure of this Sanctuary for the years 1965-66 and 1966-67 was Rs. 6,712 and Rs. 16,153 respectively. No income was derived from this sanctuary during these years.

- (b) 10.44 sq. miles.
- (c) Approximate number of inmates is 500 and it is gradually increasing.
- (d) There is no encroachment in the demarcated sanctuary area.

## Calcutta Dock Labour Board

4454. Shri Sidheshwar Prasad; Shri Sitaram Kesrl; Shri Shashi Ranjan;

Will the Minister of Transport and Shipping be pleased to state:

- (a) whether it is a fact that the Chairman, Calcutta Dock Labour Board is a superannuated person; and
- (b) if so, how many extensions have been given to him and the reasons therefor?

The Minister of Transport and Shipping (Dr. V. K. R. V. Rao): (a) Yes, Sir. The Chairman, Calcutta Port Commissioners, is also appointed as the Chairman, Calcutta Dock Labour Board. The present incumbent of both these posts is a superannuated officer.

(b) The present Chairman, Calcutta Port Commissioners, was appointed initially for a period of two years with effect from 1st April, 1962. He was granted extensions of re-employment for two years from 1st April, 1964 and one year each from 1st April, 1966 and 1st April, 1967. The extensions have been given in the public interest.

## National Highways
