8051. Shri Eswara Reddy: Will the Minister of Industrial Development - 1 Company Affairs be pleased to state:

(a) whether the investigation by the Cement Corporation of India regarding the feasibility of setting up a commt manufacturing unit at Yerraguntta in Cuddapah district (Andhra Pradesh) hus since been completed;

(b) if so, the findings thereof;

(c) whether the Cement Corporation of India propose to take up the work of setting up a cement manufacturing unit at Yerraguntta on its own; and

# Absorption of surplus Workers on Nationalisation of N.G. Sections

(a) whether 'the Railway Board have assured the West Bengal Finance and Transport Minister that it would consider the cases of re-employment of 1,500 workers, recently declared surplus after nationalisation of some narrow gauge sections; and

Poonacha): (a) No narrow gauge sections have been nationalised recently, but management of Ahmedpur-Katwa and Bankura Damodar River Railways has been assumed by Government w.c.f. 1st July, 1967. The total number of workers of these two Railways was about 800. Such of the staff of the two Railways as have been found suitable for employment on the Eastern and South-Eastern Railways in accordance with the terms and conditions decided upon by Government, and who have accepted employment on the said terms and conditions, have been taken over for employment.

(b) The service of the permanent staff of Ahmedpur-Katwa and Bankura-Damodar River Railways after their absorption, on the Eastern or the South Eastern Railway, will be treated as continuous for certain specified purposes.
