9025. Shri M. L. Sondhi: Will the Minister of Industrial Development and Company Affairs be pleased to state:

- (a) whether Government have abolished the post of Junior Technical Officers in the Directorate General of Technical Development as recommended by the Mathur Committee:
- (b) whether it is a fact that J.T.Os., having 5 years' experience in the department have been promoted to the post of A.D.O. (Engg.) in the past; and
- (c) if so, whether Covernment propose to promote the existing J.T.Os., with 5 years' experience to the post of A.D.O. (Engg.) in view of the fact that when the post of D.D.O. was abolished in the past all D.D.Os., were promoted as D.Os. in the same department?

The Minister of Industrial Development and Company Affairs (Shri F. A. Ahmed): (a) Not yet. The Study Team recommended that the grade of Junior Technical Officer with the exception of those working in the Plywood Inspectorate is not necessary and may be abolished and that the existing Junior Technical Officers, when they waste out, should be replaced by Assistant Development Officers or Upper Division Clerks. Government have accepted this recommendation subject to there being no increase in expenditure in consequence of the replacement of J.T.Os. by A.D.Os. or U.D.Cs. and the observance of the procedural requirements in case there is any ban on upgrading of the post at the time when this decision has to be implemented.

(b) Yes. Promotions to the post of A.D.O., (Engg.) in the past have been made in accordance with the provisions of the recruitment rules.

(c) Promotions of existing Junior Technical Officers with five years' experience to the post of A.D.O. (Engg.) will continue to be made in accordance with the recruitment rules. There is, however, no intention to upgrade all the posts of Junior Technical Officers to post of A.D.O.

The case of D.D.O., is not analogous to the case of Junior Technical Officers because the erstwhile grades of D.D.O. and D.O., were merged into a single consolidated grade of D.O.
