Production of Textiles

- (a) the production of textiles in the country mill made and handloom separately during 1966-67 and the per capita consumption thereof;

The Minister of Commerce (Shri Dinesh Singh): (a) Mill made cotton cloth—4203 million metres Handloom & Power loom cotton cloth—3102 millionmetres.

(b) Compared to 1965-66, production of mill made cotton cloth registered a fall whereas the production of hand-

loom and powerloom cotton cloth increased. The production in 1965-66 of mill made cotton cloth was 4402 and handloom and powerloom cotton cloth 3039 million metres respectively.

(c) During 1966-67, the cotton textile mill industry was subjected to stresses and strains due to (i) fall in purchasing power, (ii) power cuts imposed in certain States, (iii) difficult cotton situation in the country resulting in one day extra closure in a week, and (iv) shortage of finance.
