उप-प्रवान मंत्री तथा वित्त मंत्री (श्री मोरारजी देसाई) : (क) ग्रीर ख). ग्रायकर ग्रधिनियम के ग्रधीन जांच-पड़ताल ग्रभी भी चल रही है । कानून के ग्रनुसार ग्रावश्यक तलपट प्रस्तुत न करने के कारण एक कम्पनी, ग्रर्थात् कल्लीनगर एण्ड खेरल टी कम्पनी, लिमिटेड, के विरुद्ध कम्पनी कानून के ग्रधीन मुकदमा चलाया गया है ।

(ग) जिन लेन-देनों की पड़ताल की जानी है उनकी संख्या बहुत ज्यादा है तथा सक्ष्म ग्रीर व्यापक जांच-पड़ताल ग्रावश्यक है।

Plantation Ayurvedic Herbs

Recovery of Watches

(b) Investigations have revealed that the addresses of the owner of the seized car as registered with the transport authorities in Bombay and Ahmedabad were fictitious. No person has come forward to claim the car or the watches seized. The case is now under departmental adjudication.
