The Deputy Minister in the Ministry of Commerce (Shri Shafi Qureshi):
(a) The average annual production and sale of cotton, woollen and silk khadi in 1963-64, 1964-65 and 1965-66 were Rs. 23.39 crores and Rs. 21.12 crores respectively.

2390. Shri Shiva Chandra Jha: Will the Minister of Industrial Development and Company Affairs be pleased to state:

- (a) the number of firms belonging to the Groups of Birlas and Tatas;
- (b) the commodities which they produce;
- (c) the total profits Birlss and Tatas make annually:

- (d) the amount of taxes paid by them annually; and
- (e) their total assets at the beginning of the First Plan and what are these at present?

The Minister of Industrial Development and Company Affairs (Shri F. A. Ahmed): (a) and (b). As firms are dealt with by the States, information regarding the firms belonging to the groups of Birlas and Tatas cannot be furnished. The information regarding the number of companies belonging to the Birla group, their general activities as also important products being manufactured by them is set out on pages 47 to 54 of the Report of the Monopolies Inquiry Commission. Similar information about the group of Tatas is available on pages 106 to 109 of the same Report. The Report of the Monopolies Inquiry Commission was laid on the Table of the House on the 8th December, 1965.

(c) to (e). The information soughs for will have to be collected in respect of hundreds of companies and would, therefore, involve considerable labour for a long time. It would be laid on the Table of the House after the compilation of the required statistics is complete.
