secure appointment to posts in lower scales. According to existing policy of the Government, recruitment to posts other than those of Class III and Class IV or equivalent grades is made through all India advertisement. The total number of Class III and Class IV post is 13823, out of which 10742 are held by persons from Bihar.
