The Middler of Mallways (Shri C. M. Poonscha): (a) and (b). The Rai'ways are only concerned with the actual demands placed at a particular station for clearnce of goods and are not aware of the quantity and value of the goods lying in godowns.

Inspite of heavy movement of imported foodgrain, fertilizer and other high priority traffic, efforts have been made to step up loading of coir traffic from Cochin Harbour Terminus stawhich serves Mattancheri. tion. During the period from 1st March to 6th June 1967, 178 wagons of coir were loaded at Cochin Harbour Terminus. In addition, 49,937 guintals of coir fibre and coir products were also cleared as 'smalls' from this station. In order to improve despatches of coir traffic, open wagons covered with tarpaulins are also being used.
