within the powers of the Director-General of Geological Survey of India;

- (d) if so, whether it is possible to promote the employees of the Exploration Wing who had more than requisite years of service; and
 - (e) if not, the reasons therefor?

The Minister of Steel, Mines and Metals (Dr. Chenna Reddy): (a) and (b). There were as many as different cadres representing different categories of posts in the erstwhile Geological Survey of India and 153 in the Exploration Wing of Indian Bureau of Mines which have since been merged together and are now borne in a single organisation. The amalgamation of these cadres preparation of inter se seniority of the individual holders of posts in the combined organisation will necessarily take some time, as it involves detailed examination of pay scales, prescribed qualifications and other relevant particulars of various posts with a view to determining their relative position in a hierarchical pay structure and fixing them in appropriate unified scales. Determination of principles of fixing inter se seniority will also be necessary.

Inspite of the complexity of the problem, work on preparation of unified recruitment rules for gazetted cadres on the drilling side has been completed and it will be accordingly possible to fix interse seniority of the incumbents of these posts shortly. Similarly action for other posts is in progress.

- (e) The Director-General, Geological Survey of India, can promote Class II, Class III and Class IV employees on ad hoc basis only in emergent circumstances when recruitment to such posts has to be made immediately in the interest of the administration and it has to be ratified through normal procedure as soon as possible thereafter.
- (d) and (e). Such promotions are not based merely on the length of

service of officers but are primarily dependent upon administrative exigencies.
