The Deputy Prime Minister and Minister of Finance (Shri Morarji Desai): (a) and (b). The earliest and the latest surveys of foreign investments in India made by the Reserve Bank of India relate to the position as at the end of June, 1948 and March, 1965 respectively. A statement showing the break up of outstanding U.K. private investments by broad categories of industries on these dates, is laid on the Table of the Lok Sabha. Industry-wise figures of U.K. investments approved during the years 1965-66 and 1966-67 have also been incorporated in the statement laid on the Table of the House. [Placed in Library. I.A. & A.S. Officers on Deputation to Government Companies

The point of propriety underlying the question has been brought to the notice of the Comptroller and Auditor General and there is no doubt that he will, in making postings of officers immediately on reversion from such deputations, see that there is no embarrassment caused either to the company or to the officer.

Will the Minister of Finance be pleased to state:

- (a) whether it is a fact that the U.S.A. Cooperative League has offered to collaborate with the Indian Cooperative Institution in establishing fertilizer and agricultural processing industries:
- (b) if so, the major conditions of the U.S. offer; and
- (c) the reaction of Government thereto?

The Deputy Prime Minister and Minister of Finance (Shri Morarji Desai): (a) to (c). There is a proposal. to establish a fertilizer factor in the cooperative sector with the assistance of the International Co-operative Development Association of and the U.S.A.I.D. A technical team from the International Co-operative Development Association of US.A. arrived in India in June, 1967 to prepare an economic & technical feasibility report for the establishment of a plant or plants in the cooperative setor. The terms of agreement with the U.S. Cooperatives in establishing the factory will be negotiated after this report is received.

There is no offer of colaboration from the Coperative League of U.S.A. for establishing agricultural processing industries.
