when completed, will provide subscriber trunk disling facilities between these stations as well as other stations, which will be connected to these exchanges.

- (b) The Trunk automatic exchanges at Madras, Hombay and Delhi are expected to be commissioned by the end of 1967. Subscriber trunk dialling facilities will then be available between some of the stations, Madras, Hangalore, Hombay, Poona, Ahmedabad, Delhi, Chandigarh, Jullundur, Full interconnection between these stations and extensions to other stations will be done progressively.
- (c) Yes, for about three years. However, certain modifications to the Calcutta system to permit subscriber trunk dialling working into Calcutta is already on hand.
- (d) The local exchanges at Calcutta are of a special type, called the "Director System". This system was adopted for Calcutta about twenty years ago and, at that time, it provided the most flexible and economical solution for automatising the working of Calcutta and its environs. The technical features of this system are such that changes and modifications to circuits became necessary for introducing subscriber trunk dialling working. The problem was given high priority and necessary changes have been designed in India. The equipments were manufactured and tried out successfully. Full quantities of equipments for making the changes have been ordered on the Indian Telephone Industries and some of them have been delivered and the modifications are in hand.

It has in its report to the Central Board of Trustees pointed out certain deficiencies on the part of the Regional Provident Fund Office, the IBM Organisation and the Industrial establishments as a result of which there has been delay in issue of accounts slips to the subscribers. The Committee has also given certain calculations which showed that processing by manual process would cost Rs. 15.69 lakhs a year as against Rs. 17.10 lakhs by IBM Machines. Action is being taken to remove the deficiencies in question and on scrutiny it has also been found that the calculations made by Committee required correction and that the manual process was cheaper. The report of the Committee was considered by the Central Board of Trustees, Employees' Provident Fund which has decided to continue to use the machines for the pre-The Employees' Provident Fund is an autonomous Organisation and it can itself decide how it gets its accounting done.
