The Minister of State in the Ministry of Education (Shri Sher Singh): (a) By virtue of the decree passed in C.S. 18 of 1958 on the file of the High Court of Andhra Pradesh, the Salar Jung Library along with the Salar Jung Museum was vested in the Government of India. Subsequently with the coming into force of the Salar Jung Museum Act, 1961 (No. 26 of 1961) and the consequent appointment of the Salar Jung Museum Board, the Museum as well as the Library has been vested in the said Board.

(b) and (c). The entire Library including books, gatas and manuscripts in all languages whether printed or handwritten an paper or other material was included in the list marked 'B' and annexed to the compromise deed which was filed with the Decree passed by the High Court of Andhra Pradesh.

Apology Form circulated to students in M. P.

1044. Shri Deven Sen: Shri Madhu Limaye:

Will the Minister of Education be pleased to state:

(a) whether Government's attention has been drawn to the Apology Form circulated by the Madhya Pradesh Government on which signatures of college students were obtained last year;

(b) whether extraction of such apologies is held to be in conformity with the dignity of the students of free country and the principle of the Government's educational policy;

(c) whether the State Government have been advised to withdraw these forms; and

(d) if so, the reaction of the Madhys Pradesh Government thereto?

The Minister of Education (Dr. Triguna Sen): (a) and (b). Following the student disturbances at Gwalior list year, Madhya Pratesh Government required that the colleges at Gwallor which had been closed would be opened if an undertaking was given by the students that they would not indulge in any unlawful activity in future. The view of the State Government was that there is no indignity involved in giving such an undertaking.
