LOANS SANCTIONED BY AGRICULTURE FINANCE CORPORATION IN U.P.

3274. SHRI SARJOO PANDEY : Will the Minister of FINANCE be pleased to state :

(a) whether the Agriculture Finance Corporation sanctioned any loans assistance for the functioning of the agricultural projects in Uttar Pradesh during the year 1966-67; and

(b) if so, the actual disbursement of utilisation during the above period?

THE DEPUTY PRIME MINISTER AND MINISTER OF FINANCE, (SHRI MORARJI DESAI) : (a) and (b). No scheme for refinance was received by the Agricultural Refinance Corporation from Uttar Pradesh during the year 1966-67. However, one scheme received in September 1967 for sinking of tube-wells has been sanctioned in November 1967, involving a total financial outlay of Rs. 147.70 lakhs; the Corporation's commitment being Rs. 132.93 lakhs. No disbursement has so far been made against this sanction.
