(a) whether it is a fact that a housing scheme was implemented by the Department of Social Welfare in Rajasthan;

(b) if so, the names of the villages where houses have been built so far under the above scheme;

(c) the reasons for not undertaking or completing the houses in other villages; and

(d) the expenditure incurred on this scheme so far?

THE MINISTER OF STATE IN THE DEPARTMENT OF SOCIAL WELFARE (SHRIMATI PHULRENU GUHA) : (a) to (d). In the schematic budget for every Tribal Development Block, there is a provision of Rs. 1.20 lakh for 'Social Services' including housing. As the provision is limited, it is not possible to cover all villages. The names of Tribal Development Blocks in Rajasthan are given below :--

ASSISTANT ENGINEERS IN C.P.W.D.

3276, SHRI DEVINDER SINGH : Will the Minister of WORKS, HOUSING AND SUPPLY be pleased to state :

(a) whether it is a fact that recently 22 direct recruited Assistant Engineers who have not completed their training as requir-93 LSS/67-3 ed under the rules have been posted as incharge of Sub-Divisions in C.P.W.D.;

(b) whether it is also a fact that panel approved by the Departmental Promotion Committee from the grade of Section Officers for promotion to the grade of Assistant Engineers is awaiting posting; and

(c) if so, the reasons for posting the untrained direct recruits in preference to Section Officers on the approved panel?

THE DEPUTY MINISTER IN THE MINISTRY OF WORKS, HOUSING AND SUPPLY (SHRI IQBAL SINGH) : (a) and (c). The competent authority having found adequate the training imparted to some of the direct recruits for holding independent charge of Sub-Divisions it curtailed the prescribed training period in respect of 22 such direct recruits to the grade of Assistant Engineer.

(b) Owing to shortage of direct recruits in the grade of Assistant Engineer, promotion from the grade of Section Officer in excess of the quota prescribed for them has had to be resorted to. Promotion panels for regular appointment as Assistant Engineers have been exhausted. For short-term appointment of Section Officers to the grade of Assistant Engineers on an ad hoc basis pending appointment of direct recruits, panels are drawn up and one such panel is current presently. The Section Officers promoted as Assistant Engineers on an ad hoc basis are however to revert as and when direct recruits to the cadre of Assistant Engineers are available.
