

(c) Economic recovery resulting from better harvest and accelerated industrial production are likely to lead to large number of job opportunities for the unemployed, including engineering graduates.

PROPERTY BUILT FOR DISPLACED PERSONS IN DELHI

3849. SHRI S. C. SAMANTA : Will the Minister of LABOUR AND REHABILITATION be pleased to state :

(a) the number of houses, hutments and shops built by Government in Delhi for the displaced persons together with the cost involved;

(b) the manner in which these properties are rented out, sold or leased; and

(c) the annual rent of the accommodation given and the amount realised annually ?

THE DEPUTY MINISTER IN THE MINISTRY OF LABOUR, EMPLOYMENT AND REHABILITATION (SHRI D. R. CHAVAN) : (a) According to the available information, the total number of houses, hutments and shops built by Government in the rehabilitation colonies in Delhi comes to 51,886, and the expenditure incurred to Rs. 23,80,72,027/-. These figures are provisional, subject to revision in the light of reconciliation that is being conducted.

(b) These properties after construction were placed at the disposal of the Delhi Administration. They allotted them on rent to the eligible displaced persons, in accordance with the categories finalised by

them for the allotment of these properties, from time to time. No such properties are being rented out now.

All the properties, excepting a few which are non-transferable, have been disposed of by way of sale/transfer in accordance with the provisions of the Displaced Persons (C & R) Rules, 1955.

(c) The annual demand for 1966-67 of rent from the allottees of non-transferable properties was Rs. 3,17,691.25 P., while the amount realised during the year came to Rs. 3,31,904.94 P. This amount represented recoveries against the current demand as well as arrears.

BUFFER STOCK OF FOODGRAINS

3851. SHRI HIMATSINGKA : Will the Minister of FOOD AND AGRICULTURE be pleased to state :

(a) whether there is a scheme to raise buffer stocks of wheat and rice in different States;

(b) if so, the details thereof;

(c) how much of this will be created with the help of imports; and

(d) whether any progress has been made in this regard ?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND COOPERATION (SHRI ANNASAHIB SHINDE): (a) to (c). Yes, Sir. It is

proposed to build up a buffer stock of 3 million tonnes of foodgrains in different regions by the end of 1968, partly from imports and partly from internal procurement.

(d) The process has just started.

FLOUR MILL IN KANGRA

3853. SHRI HEM RAJ : Will the Minister of FOOD AND AGRICULTURE be pleased to refer to the reply given to Unstarred Question No. 7473 on the 1st August, 1967 and state :

(a) whether any application for the setting up of a medium flour mill in Kangra has since been recommended by the Himachal Pradesh Government; and

(b) if so, the decision taken thereon ?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND COOPERATION (SHRI ANNASAHIB SHINDE): (a) The Himachal Pradesh Government have again recommended that the case of the flour mill proposed to be set up at Kangra may be favourably considered.

(b) The matter is under consideration and no decision has yet been taken.

KOKTI COTTON

3854. SHRI BENI SHANKER SHARMA : Will the Minister of FOOD AND AGRICULTURE be pleased to state :

(a) whether it is a fact that kokti cotton which used to be grown extensively in the region between Banka and Deoghar in Bihar is not grown now; and

(b) if so, the steps proposed to be taken by Government to revive the production of cotton or other crops in the area ?
