(c) if so, the steps taken or proposed to be taken to remove this shortage of sugar in the market and bring down the prices?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND COOPERATION (SHRI ANNASAHIB SHINDE): (a) No, Sir. The decontrol has been in respect of 40 per cent of the sugar production.

(b) and (c). The prices of sugar in the free market have declined to some extent with the increase in arrivals. They are expected to get stabilised with the arrival of further stocks and future releases of sugar for free sale.

RECOMMENDATIONS OF WAGE BOARD ON Iron Ore Industry in Goa

3959. SHRI YASHPAL SINGH : Will the Minister of LABOUR AND REHA-BILITATION be pleased to state :

(a) whether the iron ore industry in Goa have requested for the exemption from the obligation to implement the recommendations of the Wage Board; and

(b) if so, the reaction of Government thereto?

THE MINISTER OF LABOUR AND REHABILITATION (SHRI HATHI): (a) A representation was received from the Goa Mineral Ore Exporters' Association requesting that implementation of the recommendations of the Wage Board might be held in abeyance.

(b) The request made by the Association has not been acceded to. The Association has been requested to advise its members to implement the Wage Board's recommendations.

FOOD IMPORTS UNDER PL 480

3960. SHRI YASHPAL SINGH : Will the Minister of FOOD AND AGRICUL-TURE be pleased to state :

(a) whether supply of three million tons of foodgrains to India under PL 480 during 1968 is dependent on the fulfilment of certain conditions;

(b) if so, what are those conditions, and

(c) the reaction of Government thereto?

The negotiations for getting supplies of foodgrains during 1968 from the U.S.A. under PL-480 are still in progress. The quantity which is expected to be made available under the next agreement is 3.5 million tonnes for the first six months of the year. The conditions which will be incorporated in the next agreement have not yet been finalised.

REPORTED AMERICAN INTERFERENCE WITH THE LAST GENERAL ELECTIONS IN INDIA

SHRI H. N. MUKERJEE (Calcutta North East) : I call the attention of the Minister of Home Affairs to the following matter of urgent public importance and 1 request that he may make a statement thereon :

"Reported American interference with the last general elections in India."

THE MINISTER OF HOME AFFAIRS (SHRI Y. B. CHAVAN) : Mr. Speaker, Sir, I would invite the attention of the House to the statement I had made on June 15, 1967 regarding the use of foreign funds in the General Elections. I had at that time informed the House that a report in the matter had been received from the Intelligence Bureau and was being examined carefully. It would be recalled that on December 7, 1967, the question had again come up in the course of supplementaries in response to the statement made by me regarding the reported Russian interference with the last General Elections in India. 1 had again informed the House that the entire question of the use of foreign money in the last General Elections was being examined by the Government on the basis of a report submitted by the I.B. It is not possible at this stage to indicate the time that would be taken in completing the examination, but I would like to assure the House that it would be done as expeditiously as possible.
