Information about the Statewise output capacity of gins is not available. However, the existing capacity in the country appears to be sufficient for the present size of the crop.

- (b) The gins installed in most of the factories are old but these are reported to be working satisfactorily with period i.e. replacement of the working parts like rollers knife etc.
- (c) Government of India has not drawn up any such Plan.
- (d) There is no such proposal at present.
- (e) Single roller as well as double-roller gins are indigenously available However, sawgins have to be imported.

## Recommendation for supply of Jeep to Supdt. Post Offices, Kangra Postal Division

(b) The recommendation was received on 9.7-68.

Government of India have sanctioned 2 jeeps for use in two of the border divisions of Assam on experimental basis, to study whether the advantages derived from the provision of such transport would be commensurate with the additional expenditure involved. After the results of this experiment are sifted and a final decision is taken the proposal to provide Government transport to Superintendent of Post Offices at Kangra will be examined.

## Land Leased out in Vijay Nagar, Delhi
