(c) The exemptions have been granted in pursuance of the general policy of Government that small-scale sector should be afforded some measure of protection and encouragement.

विदेश मंत्री (श्री स्वर्ण सिंह) : (क) और (ख). लंका की सरकार ने भारत सरकार से कुछ आतंकवादियों की धमकियों का मुकाबला करने के लिए सहायता मांगी थी। भारत सरकार अपने साधनों में से सभी प्रकार की संभव सहायता देने के लिए सहमत हो गई थी। हमने अघातक कार्यों के लिए हेलीकाप्टर और लंका के समुद्री किनारे की सुरक्षा के लिए भारतीय नौसेना के जहाज दिये थे। हमने अपने सामान की सुरक्षा और सही प्रयोग के लिए कुछ सैनिक और कुछ सैनिक साज-सामान भी भेजा था।

**NIRMAN AUR AWAS TATHA SWASTHYA AUR PARIVAR NIYOJAN MANTRI (SHRI UMA SHANKAR DIKSHIT) :** (a) About 1000 species of medicinal plants have been identified by the various Survey of Medicinal Plant Units functioning in different parts of the country.

(b) An expenditure of Rs. 4,34,653 has been incurred on the Survey of Medicinal Plants during 1969-70 and 1970-71.

**Scarcity of Petroleum due to demand for rise in the Prices of Crude Oil**
