Reopening of Closed Textile Mills

124. SHRI INDRAJIT GUPTA : SHRI PAMPAN GOWDA :

Will the Minister of FOREIGN TRADE be pleased to state :

(a) the number of Cotton Textile Mills lying closed in each State at present and the number of employees effected thereby;

(b) whether there is any proposal to reopen the closed mills; and

(c) what assistance the Centre will provide for reopening the mills ?

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE (SHRI A.C. GEORGE): (a) Excluding mills considered fit to be scrapped, there were 52 cotton textile mills lying closed in the country at the end of January, 1972 affecting about 53, 528 workers. The statewise break up of these mills is as follows:-

When considered necessary, the management is taken over by Government and financial assistance for working capital, modernisation etc. is provided jointly by the National Taxtile Corporation and the State Governments/State Textile Corporations concerned.

Holding back by U.S. Government Supply of PL-480 cotton

However, there have been no discussions with US on the supply of cotton under PL 480 agreement after the recent suspension of economic aid to India by U.S. Government.
