Attaching of third class sleeper coaches with trains running from Mangalore to Madras

- 134. SHRI CHANDRA SMEKHAR SINGH: Will the Minister of RAILWAYS be pleased to state:
- (a) whether no third class sleeper coach for Delhi, Bombay or Howrah is attached with the trains running from Bangalore to Madras; and
 - (b) if so, the reasons thereof?

MINISTER OF RAILWAYS THE (SHRIK, HANUMANTHAIYA): (a) One Hird class sleeper coach runs between Mangalore and Bombay Between Mangalore and Delhi, a composite 1st-cum-IIIrd class coach runs 5 days a week. No through coach runs between Mangalore and Howrah.

class (b) Composite 1st-cum-111rd coaches do not have 111rd sleeper accommodation, and there is not adequate traffic Illrd for a full sleeper coach, hence no sieeper coach runs between Mangalore and Delhi and Mangalore and Howrah.

Through trains from West Bengal Assam and Bihar to Bangla Desh

THE DEPUTY MINISTER IN THE MINISTRY OF FORFIGN TRADE (SHRI A. C. GEORGE): (a) No such proposal has taken shape.

Damage to Railways in Guiarat State due to Indo-Pak War

Will the Minister of RAILWAYS be pleased to state

- (a) the total damage caused to the Railways in Gujarat State in the last Indo-Pak war; and
- (b) the steps taken to repair the damage ?

THE MINISTER OF **RAILWAYS** (SHRI K HANUMANTHAIYA): (a) Minor damages to Rs. 30/- only were caused.

(b) Damages being minor were got repaired departmentally.

Effect of Maharashtra Power Famine on Gujarat

- 138. SHRI PRABHUDAS PATEL: Will the Minister of IRRIGATION AND POWER be pleased to state:
- (a) whether Gujarat was greatly hit by Maharashtra power famine in February. 1972:
- (b) if so, whether this unprecedented power famine has affected both industry and agriculture in Gujarat very seriously;
- (c) Whether the Gujarat Government have thrown all the blame on the Centre for its antipathy towards the issue; and

(d) if so, the reaction of the Central Government in this regard?

THE DEPUTY MINISTER IN THE MINISTRY OF IRRIGATION AND POWER (SHRI B. N. KUREEL): (a) and (b). Yes, Sir. Gujarat has been experiencing severe power shortage since end of December 1971 on account of availability of power from Tarapur Atomic Power Station located in Maharashtra to the extent of only 55 MW as against 206 MW normal supply. This has naturally affected power supply to industry, agriculture, etc. in Gujarat.

(c) and (d). At the request for assistance from Gujarat, Centre arranged for additional supply of duty-exempt furnace oil required for stepping up generation at Dhuvaran Thermal Power Station and have also arranged with the States of Maharashtra, Madhya Pradesh and Mysore to spare power to Gujarat to the maximum extent possible. Gujarat State has appreciated the timely assistance arranged by Centre for mitigating the power shortage conditions.

Assault on Divisional Superintendent, New Delhi (Northern Railway)

- 139. SHRI HARI SINGH: Will the Minister of RAILWAYS be pleased to state:
- (a) whether the Divisional Superintendent Northern Railway was assaulted in his office in Paharganj, New Delhi, by a former Railway employee on the 1st February, 1972; and
- (b) if so, the action taken by Government against the culprit?

THE MINISTER OF RAILWAYS (SHRI K. HANUMANTHAIYA): (a). Yes.

(b) The Delhi Police have registered a case vide FIR No. 91 dated 1-2-1972 under section 307/506/353/332/186 IPC and 25 Arms Act and their investigations are still in progress. The accused was arrested and released on bail by the court.

This post is lying vacant and the UPSC nominee has been sent the offer. This post is not reserved for Scheduled Castes.
