employees to secure alternative employment:

- (i) Such of those persons who have rendered six moths service are accorded Priority III for the purpose of securing alternative employment through the Employment Exchanges concerned. Those who have rendered less than six months' service will be entitled to retain the benefit of their original date of registration in the Employment Exchange concerned.
- (ii) They would also be entitled to age relaxation to the extent of the period of their service in the Census Organisation.
- (iii) The various Directors of Census Operations were instructed to issue 'No Objection Certificates' for re-registration in the Employment Exchange in respect of these employees, sufficiently in advance of their probable date of retrenchment.
- (iv) The various State Governments have been requested to consider the cases of these retrenched personnel sympathetically for alternative employment under the control of the State Governments. Several State Governments responded sympathetically to the appeal made by the Registrar General, India and have issued orders giving preference to the retrenched personnel of the Census Offices in filling up vacancies occurring under their control.
- (v) Various Public Undertakings/
  Corporations have also been requested to consider the cases of these retrenched employess sympathetically and give priority to the retrenched Census employees in the matter of recruitment to posts under their control.
- (vi) The Comptroller and Auditor General has issued instructions to all Accountants General in the country to give preference to the retrenched personnel in filling up the vacancies arising in their respective offices; those

- who have put in one years' service or more will be exempted from appearing in further test
- (vii) The Controller General of Defence Accounts has also agreed to consider the cases of such of those retrenched employees who would be referred by the Employment Exchange for suitable vacancies in a number of places, in the country.
- (c) The Bihar State Census employees Association submitted a memorandum to the Director of Census Operations, Bihar, to the effect that they would go on hunger strike before his office, if no favourable action in respect of their continued employment was taken. The temporary Census employees were engaged on work which was expected to continue only for a few months and they were fully aware of the position at the time of their employment. In view of this and having regard to the efforts made by the Government, as enumerated in the reply to part (b) above, it was considered that the proposed hunger strike was not justified.
