5891. SHRI CHANDRA SHAILANI: Will the Minister of PETROLEUM AND CHEMICALS be pleased to state:

- (a) whether Government's attention has been drawn to the editorial in the 'Times of India' dated the 13th March, 1972 under the caption "Cherry Prospects" stating that Managerial inefficiency is clearly to blame for mismanagement in the Fertilizer Corporation of India;
- (b) whether Government have also been receiving such complaints from the Members of Parliament; and
- (c) if so, the list of the complaints and the action taken in the matter so far?

THE DEPUTY MINISTER IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI DALBIR SINGH), (a) Yes, Sir

(b) and (c). Certain complaints have been received in this regard with the suggestion that the top management of the Fertilizer Corporation of India should be changed in the interests of efficiency. These are under examination.

Multipurpose Barak Project

- (a) the progress made on Muitipurpose Barak Project; and
- (b) if no progress has been made uptill now, whether Government propose to take up this Project soon?

THE DEPUTY MINISTER IN THE MINISTRY OF IRRIGATION AND POWER (SHRI BALGOVIND VERMA): (a) and (b). The project report of the Barak Dam at Bhubandhar site has been prepared by the Central Water and Power Commission and forwarded in the State Government of Assam in April, 1972. The State Government have reported that matters relating to the population affected land submerged etc. are yet to be discussed by them with Manipur State Government the project proposals finalising Thereafter, the scheme is to be processed for obtaining the approval of the Planning Commission, for its implementation as a part of the State Plan.
