- (a) the amount of the total Central Excise duty collected by Government from Tobacco Cultivation in West Bengal and the District of Cooch Behar, separately during last three years, year-wise; and
- (b) the names of the schemes for giving loans by banks to the Tobacco cultivators in West Bengal and District of Cooch Behar in particular?

(b) There are no special schemes for giving loans by banks to the Tobacco Cultivators as such, in West Bengal or in the District of Cooch Benar. However, Commercial Banks make available necessary credit for tobacco cultivation under the agricultural credit scheme, in accordance with their rules and procedures.

Formation of Tobacco Development Corporation

Proposal to Establish Forecasting Centres in the Country

The India Meteorological Department issues forecasts of drought situation a few days in advance through its various forecasting centres in the country. The Meteorological Office, Poona, also issues every year three seasonal fore-
