THE MINISTER OF INDUSTRIAL DEVELOPMENT AND SCIENCE AND TECHNOLOGY (SHRI C. SUBRA-MANIAM): (a) to (c). The NCST Panel on Education and Scientific Research has come to the conclusion that there is not adequate support for basic research in scientific disciplines in universities and institutes of higher learning. It has, therefore, proposed that

a suitable mechanism should be evolved for funding appropriately the basic research activities in the universities, IITs and similar other institutions. The recommendation is under gonsideration.
