- (b) whether a number of persons from Andhra Region in this gradation list became special grade Deputy Collectors, while their seniors in the list from Telengana Region are still working as temporary Deputy Collectors; and
- (c) whether Central Government have directed Andhra Pradesh Government to review all such promotions and bring them in conformity with the final gradation list as published?

THE MINISTER OF STATE IN THE MINISTRY OF HOME **AFFAIRS** DEPARTMENT OF THE AND IN

PERSONNEL NIWAS (SHRI RAM MIRDHA): (a) to (c). The Final comgradation list of Tehsildars Andhra Pradesh as on 1st November, 1956 was published in 1970. Till the publication of the final list, promotions had been made on the basis of the provisional list published earlier by the State Government. In view of this, some officers who became juniors in the final common gradation list were working as special grade Deputy Collectors while their seniors were working as temporary Deputy Collectors. The temporary promotions made on the basis of the provisional common gradation list could not be reviewed in view of the judgment of the Andhra Pradesh High Court in Writ Petition No. 394 of 1970 filed by Shri Mohd. Wasi Ahmed and others. The writ appeal filed against that judgment has been disposed of by the High Court on the 18th April 1973 with a direction to review the promotions in accordance with the final gradation list of Tehsildars published in 1950 within a period of 6 months. Necessary instructions for review of the earlier promotions according to the final common gradation list have been issued to the State Government.

#### Declaration of post of Deputy Collector in Telengana Region of A.P. as Selection Post

- (a) whether the post of Deputy Collector in Telengana Region, Andhra Pradesh is a non-selection post;

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS AND IN THE DEPARTMENT OF PERSONNEL: (SHRI RAM NIWAS MIRDHA): (a) to (c). In Writ Appeal No. 167 of 1967 the High Court of Andhra Pradesh had held that promotion from the post of Tehsildar to the post of Deputy Collector in the Telengana area of Andhra Pradesh should be on the basis of seniority-cum-efficiency. However, before the judgment could come to the notice of the State Government, in the affidavit filed in writ petition No. 394 of 1970, the State Government had stated that the post of Deputy Collector had to be filled in in consultation with the Public Service Commission. After examination of the position, the High Court when the Writ Appeal against State Government to clarify the position to the High Court when the Writ Appeal against the judgment in Writ Petition No. 394 of 1970 came up for hearing.
