IHE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI F. H. MOHSIN): (a) and (b). Funds are being provided for the acpuisition of land for house-sites. The scheme of subsidy for sweepers, housing and provision of housesites for Scheduled Castes engaged in unclean occupations are included in the Central Sector. For other categories of Scheduled Castes, provision is made in the State Sec. tor. The cost of housing under the Back. ward Classes Sector is generally reckoned as Rs. 1.200 per house; it is reckoned as Rs. $1,6(6)$ in black soil areas, hilly regions and remote places; in areas bordering the Himalayas and subject to heavy snowfall, it is reckoned at Rs. 2,000. Seventy five \% of the cost of construction of a house is given as subsidy and the balance can be contributed by the beneficiary in the form of cash, labour, building material ctc.


Grants-in-aid for the housing schemes are given by the Centre to the State Governments/U.T. Admns. Nin direct grant is given by the Centre to individuals.
