Development Blocks Programme in the first four years of the Fourith Plan. However it is likely that some cuts may be necessary in the last year of the Plan viz, 1973-74, not only in regard to Tribal Development Blocks but also in respect of certain other Centrally Sponsored Schemes, as a result of a general cut imposed in the Budget Estimates for the year 1973-74.

## Shortage of Coment in Kerala

7508 SHRI C JANARDHANAN Will the Minister of INDUSTRIAL DEVELOPMENT AND SCIENCE AND TECHNOLOGY be pleased to state.

(a) whether there is acute scarcity of cement in Kerala; and

(b) if so, what steps have been taken to ensure adequate supply of cement to Kerala?

THE DEPUTY MINISTER IN THE MINISTRY OF INDUSTRIAL DE-VELOPMENT (SHRI PRANAB KU-MAR MUKHERJEE): (a) and (b). There is only one cement factory in the Kerala State with an annual capacity of about 50,000 tonnes against their requirements of about six lakh tonnes per annum. Tamil Nadu is the chief source of supply of cement. In view of the power cut to the extent of 75 per cent imposed by the Tamil Nadu State Electricity Board, the Supply position of cement in the Kerala State has been affected from February. 1973.

Arrangements have been made for the supply of about 900 tonnes of cement per day to Kerala against one lakh units of power per day made available by the Kerala State Electricity Board to Tamil Nadu for making it available to the cement industry. An additional quantity of 8000 tonnes per month is also being moved from Tamil Nadu to Kerala State. Travancore Cements. Kottayam is expected to produce about 4000 tonnes per month.

## Employment for Educated Persons in States

7509 DR. H. P. SHARMA. SHRI D K PANDA.

Will the Minister of PLANNING be pleased to state.

- (a) whether any plans have been drawn out for providing employment to the educated persons in different States:
- (b) if so, the State-wise details in this regard and the allocations made to each State in this connection; and
- (c) the details of the schemes if any submitted by Rajasthan Government in this regard and Central Government's reaction thereto?

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI MÖHAN DHARIA): (a) to (c). It is presumed that the Hon. Member has in view the 'Half a Million Jobs Programme' for educated persons 1973-74. Although а number schemes were introduced for providing job opportunities for educated jobseekers from 1971-72, it was clear that an effective impact should be possible only by a massive attack on the problem. The Central Government has, therefore, made a provision of Rs. 100 creres for stimulating creation of additional job opportunities for half a million educated persons auring the current year. Preparatory work this was begun by the Planning Commission early enough and the State Governments and Union Territories were requested in January this year to formulate programmes, on the basis of detailed guidelines given to them. These schemes are under formulation by the State Governments. Proposals have so far been received from 11 States. These schemes are being discussed with the State Governments and the necessary clearance The allocations to the various State Governments under this programme are being finalised.

The Government of Rajasthan have forwarded a programme involving an outlay of Rs. 6.8 crores with an employment potential of approximately 19,500 educated persons. The scheme is under examination and it is proposed to hold discussions with the State Government shortly with a view to finalising the programme of action.
