(d) Appropriate remedical measures are being taken to get over these difficulties and expedite the commissioning of the project. Among other things, the Suppliers are also required to remedy or replace the defective machinery and equipments concerned.

## Issue of Supplements to India Code Volumes

- 165. SHRI R. P. ULAGANAMBI: Will the Minister of LAW, JUSTICE AND COMPANY AFFAIRS be pleased to state:
- (a) the steps Government have taken to bring India Code Volumes up-to-date by issuing supplements thereto at regular intervals; and
- (b) whether any specific periodicity has been decided upon within which supplements to the Code would be brought out and made available to the public.

THE MINISTER OF STATE IN THE MINISTRY OF LAW, JUSTICE AND COMPANY AFFAIRS (SHRI NITIRAJ SINGH CHAUDHARY): (a) and (b). The feasibility of printing the Replacement Series to India Code Volumes at regular intervals is being examined in consultation with the authorities responsible for the printing of Government publications. No final decision has so far been taken in the matter.

## Construction of Power Plants in Tamil Nadu

166. SHRI R. P. ULAGANAMBI: Will the Minister of IRRIGATION AND PO-WER be pleased to state:

- (a) the number of plants being constructed in the State of Tamil Nadu with the help of Central Government at present; and
- (b) the total assistance given by the Central Government to each of the proiects?

THE DEPUTY MINISTER IN THE MINISTRY OF IRRIGATION AND POWER (SHRI BALGOVIND VERMA):

(a) There is one Central Sector power project. namely Kalpakkam Atomic Power Station, which is currently under construction in the State of Tamil Nadu.

(b) The entire expenditure, estimated at Rs. 147.73 crores is being borne by the Centre.
