Raise in price of Vanaspati by Hindustan Lever

- (c) on how many occasions, during the last 2 years prices of vanaspati product_S were allowed to be enhanced:
- (d) the extent of and reasons for enhancement on each occasion;
- (e) what are the arguments of the company in favour of the recent price hike; and
- (f) whether the Government agree with the arguments put forward by the Company?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI ANNA SAHEB P SHINDE) (a) and (b) Hindustan Lever Ltd maintained the.r for prices of vanaspati unchanged about a week after removal of statutory control on the 5th January, 1975 Thereafter, increases averaging 64 paise per kg (with zonal variations) were effected on the 13th January, 1975 and reductions averaging 35 paise per kg. on the 24th February, 1975. other factories have also been effecting increases and reductions more or less of the same order.

(c) The prices were raised on five occasions but also reduced on two occasions

The increases/reductions were necessitated mainly by the upward/downward fluctuations in the prices of raw oils used by the industry and only to such extent as could not be avoided through adjustments in the level of through of imported oils, which too was eventually discontinued in June, 1974.

- (e) The firm has attributed the increase in prices effected by it on the 13th January, 1975 to the substantial increase: in (i) packing costs, (ii) cost of chemicals and (iii) cost of electricity, coal and furnace oil, since the price structure of the industry was last enquired into by the Tariff Commission.
- (f) The vanaspati industry had, for some time before decontrol, been representing against the inadequacy of the notified prices, and a few factories had even challenged these prices in court. In view of this, some increase in price following decontrol was only to be expected.
