Agency for Distribution of Central Relief Funds in States

THE DEPUTY MINISTER IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI **PRABHUDAS** PATEL): (a) and (b) Following of the Sixth Finance recommendations Commission, the previous policy of providing non-Plan Central assistance to States for meeting expenditures necessitated by natural calamities has been rescinded with effect from the 1st April, 1974 cording to the present policy, Central assistance is made available to the States, wherever essential only by way of advance assistance for the State Plan or under the Drought Prone Areas Programme etc Such advance Plan assistance is to be set off against the normal Plan assistance due to the State in the 5th Plan period assistance to be made available is determined on the basis of assessment by the Centre regarding the extent and severity of the natural calamities the size and content of the State's Plan outlay, the resources position of the State etc. change is visualised in this policy.

Restrictions on Drought Relief Expenditure in Orissa

THE DEPUTY MINISTER IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI **PRABHUDAS** PATEI): (a) (b) Following and recommendations of the Sixth Commission, the previous policy of providing non-Plan Central assistance to the States for financing expenditures necessitated by natural calamities has rescinded with effect from the 1st April. 1974 As from 1974-75, Central assistance will be provided to the States for this purpose, only by way of advance of Plan assistance or assistance under the Drought Prone Areas Programme, etc. Such advance Plan assistance will be set off against the normal Plan assistance due to the State in the Fifth Plan period. The underlying principle behind this nolicy is that the should result in the moneys expended creation of durable and productive assets to the community and that the relief works should form an integral part of the overall developmental Plan of the States It is felt that within the parameters of this policy it is possible to provide adequate Central assistance to the States affected by natural calamities No change is envisaged in this policy.

Following the nolicy outlined above advance Plan assistance of Rs 791 crores was provided to the Government of Orissa in 1974-75

Export of Wheat and Rice to Oil **Producing Countries**

7801. SHRI JYO11RMOY BOSU: Will the Minister of AGRICULTURE AND iRRIGATION be pleased to state:

- (a) whether the Union Deputy Minister for Education, Social Welfare and Culture, Shri D. P. Yadav, told in Katihar (Bihar) on 9th March, 1975 that "India is in a position to earn foreign exchange by exporting wheat and rice to oil producing countries", and
- (b) if so, the facts thereof and Government's reaction thereto?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI ANNASAHEB P. SHINDL): (a) and (b) Except for exporting small quantities of superior basmatil rice, India is, for the present importing toodgrains for meeting the requirements of public distribution system. The statement made by Shri D. P. Yadav in Katihar was to the effect that considering the large areas of tertile land in India and the huge manpower available, if scientific cultivation were adopted, India should be surplus m food production and may be able to export food instead of importing as at present.
