उद्योग मंत्रालय में राज्य मंत्री (श्री ए० पी ल शर्मा): (क) से (ग). खादी तथा ग्रामोद्योस भायोग ने खादी तथा मिछीग भायोग कर्मचारी (उपदान) विनियम. नामक विजियम बनाये हैं जो 1 स्रप्रैल, 1967 से लाग हैं। ये नियम निम्नलिखित वर्गों के कर्मचारियों को छोड कर ग्रायोग के व्यवसायिक कर्मचारियाँ महित नियमित तथा अस्थायी संस्थानों के पूर्णकालिक कर्मचारियों पर लागू होते हैं:--

#### Freedom Fighters getting Pension by Fraudulent Mesns

1430. KUMARI KAMLA KUMARI: Will the Minister of HOME AFFAIRS be pleased to state;

- (a) the total number of complaints received from the public against persons getting pension from the Government as freedom fighters by fraudulent means;

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI F. H. MOHSIN): (a) Upto 15-8-1976, complaints in 4383 'ases against the grant of pension to freedom fighters who are not eligible for the same under the Scheme, have been received

(b) and (c). The complaints received are examined in consultation with the State Government/U.T. Admn. concerned wherever necessary. So far, pension has been cancelled in 148 cases, restored in 292 cases and suspended in 2925 cases pending further investigation.

#### Functioning of Bose Institute, Calcutta

1431. SHRI B. K. DASCHOU DHURY: Will the Minister of PLANN-ING be pleased to state:

(a) whether Government have received large number of complaints against functioning of the Bose Institute at Calcutta; and (b) if so, the nature of such complaints and action taken by Government thereon?

A number of complaints on administrative and financial matters received against the Bose Institute, were investigated by a team of officers of the Department of Science and Technology. The complaints were found to he generally vague and unsubstantiated. The procedural and administrative measures recommended by the team are being implemented.
