- (c) With a view to maximising the generation of power from the existing thermal capacity, the following major decisions were taken in the Conference—
 - (1) Determined efforts should be made to reduce the duration of both scheduled and forced outages of thermal plants.
 - (ii) Immediate action should betaken to introduce preventive maintenance techniques in a scientific manner.
 - (111) Appropriate action should be taken for prompt repairs and maintenance works.
 - (iv) Steps should be taken to reduce partial outages.
 - (v) BHEL and Instrumentation Limited, Kota Engineers alongwith representatives of the CEA would visit power stations to diagnose the ills and suggest remedial measures.
 - (vi) The BHEL would stock slow moving spare parts for Russian and American machines and would also stock spare parts for their own machines.

(vii) It was recognised that the various constituents must observe discipline in respect of frequency control, load despatch, etc. in the integrated functioning of their grids on a regional basis so that the maximum benefits of integration are derived

(viii) Importance of adopting professional management techniques and making adequate training arrangements was appreciated.

Damage to Tarapur Atomic Power Station due to Fire

THE PRIME MINISTER, MINISTER OF PLANNING, MINISTER OF ATO-MIC ENERGY, MINISTER OF ELEC-TRONICS AND MINISTER OF SPACE (SHRIMATI INDIRA GANDHI): (a) to (d). A transformer of the Maharashtra State Electricity Board located near the Switchyard of the Tarapur Atomic Power Station was damaged by fire on 12th July, 1976. The working of the TAPS was interrupted for a few hours by this incident. The quantum of work involved in repairing the transformer. 'the time that will be taken for repairs, and the cost of the repairs are being assessed by the Maharashtra

State Electricity Board. The fire appears to have been caused by a defect in the transformer equipment.

Shortage of Hard Coke from the stock lying at Coke Oven Plant in Giridih Collieries
