Preservation of Cellular Jail at Port Blair

The intention has been to

preserve the Central Tower and the existing three wings of the Jail. For this purpose, works estimated to cost about Rs. 4 lakhs have been approved, and the work is in progress. It is expected that the entire approved programme would be executed by the end of next financial year.
