(c) whether Committee has also suggested the setting up of a central magnetite plant by C.I.L. to overcome the difficulties of the washeries in utilising magnetite for washing purposes;

(d) what are the other suggestions made by the Committee; and

(e) how far they have been accepted by the Government?
