Steep increase in Power Generation during the year 1975-76

1562 SHRI ARVIND M. PATEL: SHRI VEKARIA: SHRI S. M. BANERJEE:

Will the Minister of ENERGY be pleased to state:

- (a) whether there has been steep increase in the power generation in the country during the year 1975-78;
- (b) if so, the extent of increase achieved during 1975-76 in companison to the preceding two years; and
- (c) to what extent the demand of power is being met for different purposes in various States (State-wise)?

THE DEPUTY MINISTER IN THE MINISTRY OF ENERGY (PROF. SIDDHESHWAR PRASAD): (a) and (b). The total power generation in the country during 1975-76 was 13 per cent higher then in 1974-75 and 20 per cent higher than in 1973-74.

(c) By and large power requirements, including those of the priority sectors of the economy, are being met in all the States, except in Madhya Pradesh, Maharashtra, Goa, Karna-

taka, Tamil Nadu, West Bengal and the N. E. Region where varying degrees of restriction on maximum demand and/or energy are in force. The details of power cuts and restrictions in force in these States are indicated in the Statement laid on the Table of the House. [Placed in Library. See No LT-11223/76]. Power cuts on industries and tea factories in Lower Assam have been lifted from August 11 till the end of September, 1976.

Time taken for Commissioning of a **Power Plant**

SIDDHESHWAR PRASAD); (a) The time taken for commissioning the first unit of a hydro-electric plant from the date of sanction normally varies from 5-8 years in India depending upon the extent to which project has been investigated. The time taken for commissioning thermal power plants has in the past varied from 4 to 6 years from the date of sanction.
