(5) उर्वरकों तथा ग्रन्य कृषि मादानों की खरीद के लिए किसानों को ऋण देने की व्यवस्था की जा रही है।

जहां तक कीटनाशी श्रौषधियों का संबंध है, राज्य सरकारों तथा संस्थागत एजेंसियों ने भ्रनेक डिपो खोले हैं श्रौर उनके पास देश में लगभग 52,000 वितरण केन्द्रों का एक विस्तृत जाल है । भारत सरकार भी एक योजना कार्यान्वित कर रही है, जिसके प्रन्तर्गत उत्पादन तथा कुछ महत्वपूर्ण कीटनाशी श्रौषधियों (विशुद्ध सामग्री) के श्रायात का 50 प्रतिशत सीधे राज्य सरकारों को विनिर्माण एवं किसानों को सप्लाई करमे के प्रयोजन के लिए श्रलाट किया जाता है । कुछ महत्वपूर्ण वाणिज्यिक फसलों के मामले में कीटनाशी श्रौषधियों के सतही/हवाई छिड़काव के लिए राज-सहायता दी जा रही है ।

## Books of 20 Point and 5 Point Programme Prescribed as Text Books

3139. SHRI ANANT DAVE: Will the Minister of EDUCATION, SOCIAL WELFARE AND CULTURE be pleased to state:

(a) the number and names of books on 20 point programme of the former Prime Minister Indira Gandhi and 5 point programme of Sanjay Gandhi prescribed as text or reference books in various schools and colleges of the country; and

(b) the facts thereabout and the reaction of Government in this respect?

THE MINISTER OF EDUCATION, SOCIAL WELFARE AND CULTURE (DR. PRATAP CHANDRA CHUNDER): (a) According to information available with the Ministry of Education and SW, a book on 20 Point Economic Programme and the 5 Point Programme entitled "Pragati Ke Path Par" was published and prescribed by the Delhi Administration in December 1976 as a supplementary text book for Classes 9 and 10 for schools in Delhi.

(b) Originally, instructions were issued by the Delhi Administration that question(s) carrying 5 marks should be set from this book. But the instructions were subsequently withdrawn by the Delhi Administration on 24th March, 1977.

#### Complaint against the Gujranwala House Building Cooperative Society, Delhi

3140. SHRI RAM KANWAR BERWA: Will the Minister of WORKS AND HOUSING AND SUPPLY AND REHA-BILITATION be pleased to state:

(a) whether any complaint has been received by the Registrar of Cooperative Societies, Delhi that the Gujranwala House Building Cooperative Society, Delhi is making alterations and additions in the List of names of the left out members of the Society who are yet to be allotted plots and for whom additional land has been allotted to the Society by Government; and

(b) if so, the nature of the complaint and measures being taken or proposed to be taken to safeguard the interest of the left out members who are waiting for allotment of plots for the last 18 years and so?

THE MINISTER OF WORKS AND HOUSING AND SUPPLY AND REHA-BILITATION (SHRI SIKANDAR BAKHT): (a) Yes, Sir.

(b) The Delhi Administration has made an enquiry. Appropriate action will be taken according to law.

कृषि ग्रौर सिंबाई मंत्री (श्री सुरजीत सिंह बरनाला): (क) देश में भारतीय वन्य जीव परिषद् जैसी कोई संस्था नहीं है। देश में भारतीय वन्य प्राणी मण्डल नाम की संस्था ग्रवध्य है जिसका 4 वर्ष की ग्रवधि के लिए 4 जुलाई, 1974 को पुनर्गठन हुग्रा था। ग्रत: इसका 4 जुलाई, 1978 को पुन: पूनगंठन होना है।

(ख) भारतीय वन्य प्राणी मण्डल एक सलाहकार निकाय है । इसके विषय में इस प्रकार का कोई प्रस्ताव विचाराधीन ' नहीं है ।

(ग) प्रश्न ही नहीं होता ।

### Persons Sent to U.K. for Training by 1.I.T., Delhi

3142. DR. RAMJI SINGH: Will the Minister of EDUCATION, SOCIAL WELFARE AND CULTURE be pleased to state:

(a) whether  $tw_0$  persons from I.I.T., Delhi were sent to U.K. for training; if so, the nature of training; and

(b) whether it is the policy of Indian Institute of Technology to get persons from I.I.T. trained in foreign countries?

THE MINISTER OF EDUCATION, SOCIAL WELFARE AND CULTURE (DR. PRATAP CHANDRA CHUNDER) 1421 LS-7.

(a) and (b). The Government of India have collaborative arrangements with the Government of U.K. for the development of the IIT Delhi. Initially, the scheme of collaboration was established for a period of three years viz., 1968-70 and was subsequently renewed for a further three year period from April 1971 to March 1974. In April 1974 the agreement was extended for a further two year period ending March The present agreement of col-1976. laboration commences on 31st April, 1976 and is valid for a period of five years.

The purpose of collaboration is to assist the I.I.T. to serve the needs of Indian Industry, as defined in - the Government of India's plans, through projects of research and development. The collaboration is also meant to assist the I.I.T. in developing its educational role.

From 1-4-1976 upto date, seven persons were sent to U.K. utilising the provision of visits under this agreement, for training in University Administration, and operation of N.C. Machines, and for discussion with the British authorities.

# Final Decision regarding Abolition of Lease of D.D.A. Flats
