(b) Railways have taken a umber of steps such as adoption of modern culinary techniques, use of modern kitchen gadgets and equipments, setting up of base kitchens to provide 'ready-to-serve' meals on trains, procurement of raw material and ingradients from standard sources etc. to further improve the quality of service and food on trains.
