(b) and (c). The cost of pipes being imported for the Salaya-Viramgam-Koyali section of the crude oil pipeline project is about Rs. 14.17 crores.

The Kourkela Steel Plant is the only manufacturer of pipes of API quality required for the pipeline project Supply of nearly 13,200 MTs of 18" diameter pipes for the Viramgam-Koyali Section has been made by Hindustan Steel Plant (HSL). Orders have been placed with HSL for 87,000 MT of 24" pipes for the Viramgam-Mathura Section. The delivery has to be completed by March 1979. If HSL is not able to keep upto this delivery schedule, certain quantity of pipes will be required to be imported for this Section also. This will be decided in consultation with HSL.

Oil Exploration in Jaiselmer Area

- 3213. SHRI S. R. DAMANI: Will the Minister of PETROLEUM AND CHEMICALS AND FERTILIZERS be pleased to state:
- (a) whether it is a fact that Government has decided to stop oil exploration work in the Jaiselmer area;
 - (b) if so, the reasons thereof; and
- (c) if not, the results of the work carried on so far and the prospects of finding oil in the region capable of commercial exploitation?

THE MINISTER OF PETROLEUM AND CHEMICALS AND FERTILIZERS (SHRI H. N. BAHUGUNA): (a) No. Sir.

- (b) Does not arise.
- (c) Except for a small gas find at Manhera Tibba, which was not of commercial significance, no hydrocarbons have so far been found in Rajasthan. Drilling there is being temporarily suspended for reinterpretation of the available data, on which would depend the future course of action.

Dieselisation of Trains Running on Mangalore-Trivandrum Section

- 3214. SHRI VAYALAR RAVI: Will the Minister of RAILWAYS be pleased to state:
- (a) whether Government are aware of the heavy rush of passengers in the Mangalore-Trivandrum section of Southern Railway:
- (b) whether Government propose to dieselise the trains in this section and include more compartments;
 - (c) if so, the details thereof; and
- (d) other steps Government propose to take to increase the convenience of passengers there?

THE MINISTER OF RAILWAYS (PROF. MADHU DANDAVATE): (a) An analysis of occupation of 29/30 Mangalore-Trivandrum Malabar Express and 47/48 Cannanore-Trivandrum Express has shown that these trains are overcrowded on certain sections.

- (c) Does not arise.
- (d) Arrangements are being made to augment the loads of 29/30 Malabar Express and 47/48 Cannanore-Trivandrum Express by two and one second class coaches respectively.

रेस मंत्री (प्रो० मधु वंडवते): (क)

Decision to introduce decasualisation Scheme

- (b) if so, whether this scheme has been implemented at all railway stations over Northern Railway and other Zonal Railways; and
- (c) the details of stations over Northern Railway and other Zonal Railways where this scheme has not been implemented so far with reasons therefor?

(b) and (c). Yes, except at Allahabad Jn. station on the Northern Railway, where a Cooperative Society of the porters, M/s. Railway Station Porters' Cooperative Labour Contract Society Limited, Allahabad, is functioning. The question of introducing decasualisation scheme at this station is under consideration of the Railway Administration.
